- We won't sell or give away your name, mail address, phone number, email address or any other information to anyone.
- We'll use state-of-the-art security measures to protect your information from unauthorized users.

### NOTICE

We will ask you when we need information that personally identifies you (personal information) or allows us to contact you. Generally, this information is requested when you create a Registration ID on the site. We use your Personal Information for four primary purposes:

- To make the site easier for you to use by not having to enter information more than once.
- To help you quickly find, services or information regarding your account with us.
- To help us create content most relevant to you.
- To alert you to service upgrades, special offers, updated information and other new services from our company

### CONSENT

If you choose not to register or provide personal information, you can still use some of this site; however, you will not be able to access areas that require registration.

## **ACCESS/Patient Profile**

We create a personal profile for you from your registration information. If you ever want to review or update that information, you can log in and select Profile Center, click on Update Profile, and edit any of the Personal Information in your profile.

This ensures that only you can access your information, as well as providing you with the means to ensure that your personal information is correct and current. You may review and update this information at any time on your profile. There, you can:

- View and edit personal information you have already given us.
- Opt-in or Opt-out for electronic statements (e-statements)
- Change your email address and your password.

## **SECURITY**

Our company has taken strong measures to protect the security of your personal information and to ensure that your choices for its intended use are honored. We take strong precautions to protect your data from loss, misuse, unauthorized access or disclosure, alteration, or destruction.

We guarantee your e-commerce transactions to be 100% safe and secure. When you place orders or access your personal account information, you're utilizing secure server software SSL, which encrypts your personal information before it's sent over the Internet. SSL is one of the safest encryption technologies available.

Also, your transactions are guaranteed under the Fair Credit Billing Act. This Act states that your bank cannot hold you liable for more than \$50.00 in fraudulent credit card charges. If your bank does hold you accountable for \$50.00 or less, we'll cover your liability provided the unauthorized, fraudulent use of your credit card resulted through no fault of your own and from purchases made from us over our secure server. In the event of unauthorized use of your credit card, you must notify your credit card provider in accordance with its reporting rules and procedures.

Our company strictly protects the security of your personal information and honors your choices for its intended use. We carefully protect your data from loss, misuse, unauthorized access or disclosure, alteration, or destruction.

Your personal information is never shared outside the company without your permission, except under conditions explained above. Inside the company, data is stored in password-controlled servers with limited access.

You also have a significant role in protecting your information. No one can see or edit your personal information without knowing your user name and password, so do not share these with others.

## **DIGITAL PAYMENTS**

When you join us, you provide us with your contact information, including an email address. We use this information to send you updates about your account as well as any payment due. When selecting to make an online payment, we ask for your credit card number and billing address. We use this information only to bill you for services received and billed for by your healthcare provider. With your authorization, we can save your billing information should you want to pay with this card again. However, we don't save this information without your permission.

We do not issue refunds for online bill payments made through this site once the payment has been completed by yourself. Should you experience any issues with making a payment, we recommend that you contact us immediately by calling the telephone number on your statement.
